COVID-19 CONDITIONS OF ENTRY NOTICE FOR ACCESS CARD USERS



REGARDING COVID-19

The purpose of this notice is to outline changes to the conditions of your entry to the MMA Market Site during this Pandemic COVID-19 period.

To assist in containing the spread of Coronavirus Disease 2019 (COVID-19) and reduce the risk of exposure to Market users, MMA requires you to comply with these modified conditions of entry to the Market.

COMPLIANCE NOTICE

THIS IS AN IMPORTANT DOCUMENT: YOU MUST READ IT CAREFULLY

During this COVID-19 outbreak the MMA conditions of entry to the Market site have been altered to reduce the likelihood of Market staff and users being exposed to or spreading the infection. These measures reduce the risk to ALL Market staff and users, but are also important for the health and wellbeing of the broader community. MMA reserves the right to take any action it considers appropriate against a person who refuses to cooperate and makes a false declaration.

MMA reminds you that it is your obligation to comply with all relevant State and Federal laws and the advice and directions of Government Authorities in response to COVID-19

As now required by the Australian government and in line with MMA Pandemic Plan guidance, entry restrictions apply to the following Market Access Card holders.

- Those who have returned from international travel on or after 16 March 2020 are excluded from entering the Market site until they have completed the mandatory 14-day self-isolation.
- Those who have had close contact with any person suspected of having COVID-19 in the past 14 days.
- Those who have experienced COVID-19 symptoms (including temperature of 38°C or greater, cough, shortness of breath) in the past 14 days.

If you fall into any of these categories, you will be denied access to the Market. You should be either seeking medical advice or practising self-isolation. For Contractor and Supplier personnel, you must inform your manager and MMA representative. If there are any particular requirements or policies which apply to your organisation, you should also comply with those arrangements.

If you believe that there is a particular exception which applies to you, please advise and MMA can take that into consideration.

Mandatory temperature tests on arrival

- On your arrival to the Market site daily, you will be required to undertake a compulsory temperature test using an infrared (non-invasive) device.
- Subject to dot point 3 below, if your temperature is 38°C or higher you will NOT be permitted to enter the Market Site,
- Subject to dot point 3 below, if you refuse to participate in the temperature test, you will NOT be permitted to enter the Market Site. For employees, this may also give rise to disciplinary consequences.
- The above-mentioned dot points do not apply if you provide the MMA / tester with a current medical certificate from a qualified medical practitioner clarifying:
 - That you have no risk of COVID-19 and providing an explanation of the fever (where applicable); and/or a medical explanation of why you are unable to undertake the temperature test, in which case the MMA General Counsel & Head of Property (or his delegate) has the sole discretion to approve entry into the Market.
- MMA will not retain any personal or health information arising from the test.
